## Governor's Report

I'm almost a "lame duck" at this point, but I still have a few things to say. And by the way, voting for our new Governor continues through March 14. You can vote on line.

One of the big topics under consideration at Board of Governors' meetings for the past three years has been the continuous strategic planning initiative. The MAA is designating three topics per year for committee study and focus group discussion, with a final committee report and recommendations being produced after at most two years. There could thus be as many as six strategic planning committees in action right now. The topics for the first two cycles have been Professional Development, Revenue, AMC, Membership, Governance, and Students. As a result of the Revenue study, there has been a revision of the MAA dues structure. It's still complicated and could be a rich source for word problems, but the goal was to produce a more equitable plan without seriously damaging the organization's revenue stream.

As for the AMC (American Mathematics Competitions), last year I reported to you that institutions of higher education now have the opportunity to serve as host sites. We did this at UL Lafayette. The designated testing date was February 21, Ash Wednesday, the day after Mardi Gras. I thought that might be a bad date for us, and didn't know what to expect, but 39 kids showed up for the tests. A crew from our Enrollment Services Office
gave a brief recruiting pitch and passed out donuts, some t-shirts, and literature. The response was actually better than I had anticipated, and we drew in some students whose schools had never participated in the AMC. We are already planning to do this again next year, with better publicity.

My term as Governor ends on July 1. I have really enjoyed it, and like to think that I made positive contributions to the Board. Thank you for allowing me to represent you. The MAA is a very healthy and successful organization. The professional staff, elected officers, and committee members are for the most part intelligent, energetic, and dedicated. And nice people. If you possess some of the above qualities, I recommend that you become more involved with the MAA. If you are lucky you will get as much from it as I have.
