2009 DISTINGUISHED TEACHING AWARD



At the annual section meeting last year, Dr. Vic Schneider, Professor of Mathematics at the University of Louisiana at Lafayette, was selected as the recipient of the Louisiana/Mississippi Section Distinguished Teaching Award for 2009.

Vic Schneider earned a degree in Mathematics from USL (now UL) in 1966. In 1970, he earned a PhD in Mathematics from the University of Massachusetts, writing a dissertation in Topology, directed by Professor Larry Mann. After graduation, he returned to his Alma Mater, where he has spent these last 40 years teaching and studying Mathematics. He has authored, or co-authored, 27 research papers and sponsored, or co-sponsored seven PhD students. He has also served a department head and graduate coordinator. For the last 15 years he has been heavily involved with in-service workshops for mathematics teachers.

The Outstanding Teacher Award Committee seeks nominations for 2010. We need you to nominate your deserving colleagues for the Section Distinguished Teaching Award!! Recipients of this award also serve as the section's official nominee for the MAA's Haimo Award. The amount of work required to nominate someone is pretty minimal so please consider following through on this today. The typical nomination packet includes the nomination form (available from the link below), a narrative describing the nominee's teaching success, some evidence of the nominee's teaching success, and up to five one-page letters of recommendation, at least two of whom should come from the nominee's students or former students. The deadline for submissions is **February 15, 2010**.

Eligibility:

In order to be considered eligible for this award, a nominee must satisfy each of the following criteria:

1. Any nominee must be a college or university teacher assigned at least half-time during the academic year to teaching a mathematical science in a public or private college or university (from two-year college teaching through teaching at the Ph.D. level) in the United States or Canada. Those on approved leave (sabbatical or other) during the academic year in which they are nominated qualify if they fulfilled the requirements in the previous year.
2. Any nominee must have at least 5 years of teaching experience in a mathematical science.
3. Any nominee must be a member of the Mathematical Association of America.

Nominees will be judged on the following criteria:

1. Is the nominee widely recognized as extraordinarily successful in teaching? Teaching can be interpreted to be more than classroom teaching. It could also include activities such as preparing students for competitions, attracting students to become majors in a mathematical science or to become Ph.D. candidates, etc.
2. Has the nominee's teaching effectiveness been well documented?
3. Has the nominee had an influence in teaching beyond his/her own institution(s)? This can take on many forms such as making a lasting impact on alumni, providing influence on the profession through curricular revisions in college

mathematics teaching, making contributions to influential innovative books on the teaching of college mathematics, etc.

4. Has the nominee fostered curiosity and generated excitement about mathematics in his/her students?

To submit a name to the committee:

In order to be considered, nominations must be submitted on the Nomination Form. If you need a copy of the Nomination Form, you may get a copy of it from our section's webpage. Completed nomination packets should be sent to the Committee Chair. For consideration, a complete nomination packet must be received by the deadline.

In addition, the Section NExT Program will attend the Distinguished Teaching Address on Saturday morning by Vic Schneider (ULL). All National NExT Fellows are welcome to join us.

Section NExT (New Experiences in Teaching) is a two year professional development program designed for new college and university faculty holding a masters or doctorate in the mathematical sciences. It addresses the full range of faculty responsibilities including teaching, scholarly activities, and service.

This slate will include nominees for the offices of:

1) Section Chair: This person will serve as the program chair and coordinator for the Spring 2011 meeting of the Section, and chair the Executive Committee of the Section. The Loc. and Nom. Committee will be nominating Laura Sheppardson who has served as MS Vice-Chair over the past year and who has graciously agreed to host the 2011 Section meeting.

2) Vice-Chair for Louisiana: This person is agreeing to serve for 1 year to help the Section Chair and to serve on the Executive Committee, but they would also be agreeing for next year's Locations and Nominations Committee to nominate them for Section Chair. Call for Student Papers

The LA/MS Section of the MAA will hold its annual Student Paper Competition at the Spring section meeting. Papers are solicited in two categories: graduate and undergraduate. The graduate category is limited to master's students. Ph.D. students are encouraged to submit for the contributed paper sessions listed above. Presentations at the meeting will be limited to 12 minutes.

Send your name, school, and a short abstract (50 words or less) to Dr. Danny Acosta, dacosta2@selu.edu. Abstracts and papers should be submitted electronically to Dr. Acosta as an email attachment in Microsoft Word. The deadline for submission of abstracts is **February 22, 2010**.

A written paper of 6 pages or less must be received and include the author's name, institutional affiliation, faculty advisor and an e-mail address. Late entries will not be considered. Contact the Student Papers Committee Chair or the Rules for Student Papers for more details.

Prizes will be awarded in each category separately, with no more than 3 prizes in each. The number of prizes awarded shall be at the discretion of the judges, and shall be determined depending on the number and quality of the entries in each category. The amount of the prizes shall be as follows: first prize, \$100.00, second, \$75.00, and third, \$50.00.

Each entry will be judged on the basis of both the written and oral presentation, with equal consideration given to both.

Student Paper Competition

The LA/MS Section of the MAA will hold its annual student Paper Competition at the Spring Section meeting. Send an electronic abstract and an electronic copy as an email attachment in WordPerfect, Microsoft Word, or PDF format to Dr. Danny Acosta (dacosta2@selu.edu.) by **February 22, 2010**.

- There are two categories of papers: graduate and undergraduate. The graduate category is limited to master's students. Ph.D. students are encouraged to submit for the contributed paper sessions.

- Presentations at the meeting will be limited to 12 minutes.
- A written paper of 6 pages or less must be received and include:
 - author's name
 - institutional affiliation
 - faculty advisor
 - email address
- Prizes will be awarded in each category separately, with no more than 3 prizes in each.
- The number of prizes awarded shall be at the discretion of the judges, and shall be determined depending on the number and quality of the entries in each category.
- The amount of the prizes shall be:
 - For undergraduate papers:
 - first prize, \$100.00
 - second, \$75.00
 - third, \$50.00.
 - For graduate papers:
 - first prize, \$100.00
 - second, \$75.00
 - third, \$50.00.
- Each entry will be judged on the basis of both the written and oral presentation, with equal consideration given to both.
- All graduate papers are eligible for the graduate prizes.



Student Competition

The student team competition will be held at the Spring Section Meeting on **Friday, from 8:00 – 11:00 a.m.** Sponsors, be sure to have your teams ready to check in on time on Friday morning.

CONTEST RULES

1. Each institution may send at most two teams, each team consisting of at most four students. The four students within one team may work together on problems. Students may not get help from people on other teams, even if from the same school.
2. Participants must be undergraduate students and currently enrolled at the institution they represent. This means that the student has not yet earned a bachelor's degree--exceptions for students who are returning back to school to pursue a second bachelor's degree when the first degree was not in a mathematical area may be considered. A student from abroad who has completed training equivalent to an American bachelor's degree and who is taking solely graduate-level courses in a graduate program will be ineligible.
3. Each team must have a faculty sponsor.
4. Calculators comparable to the TI-85 without a symbolic manipulator will be allowed. Calculators with a symbolic manipulation capability, such as the TI-92 or TI-89+, are not allowed.
5. The contest will last 2 hours.
6. The Competition Committee is solely responsible for interpreting the rules and for ruling on any unforeseen situation.
7. Cash prizes will be awarded for 1st place (\$100), 2nd place (\$75), and 3rd place (\$50) teams.

CONTEST PROBLEMS

The contest will consist of 2 groups of problems. Each team may choose any 5 problems from Group II.

Each problem will be worth 10 points. The problems are from the following areas:

 Abstract Algebra (1 problem)
 Advanced Calculus (1 problem)
 Differential Equations (1 problem)
 Discrete Mathematics (1 problem)
 Linear Algebra (1 problem)

 Advanced Calculus (2 problems)
 Differential Equations (1 problem)
 Multivariable Calculus (1 problem)
 Geometry (1 problem)
 Point-Set Topology (1 problem)
 Probability/Statistics (1 problem)
 Set Theory/Logic (1 problem)

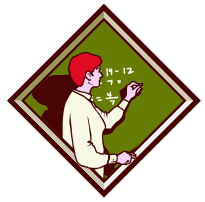
